TOURNAMENT RULES/INFORMATION

1. ALL BOWLERS MUST BE USBC MEMBERS IN GOOD STANDING. ALL PARTICIPANTS WILL BE REQUIRED TO SHOW THEIR USBC CARDS WHEN CHECKING IN.
2. BOWLERS WILL USE THEIR PREVIOUS SEASON'S HIGHEST BOOK AVERAGE. IF A BOWLER HAS A CURRENT AVERAGE FOR 21 OR MORE GAMES THAT IS 10 PINS OR MORE HIGHER THAN THE PREVIOUS SEASON'S AVERAGE, THE CURRENT AVERAGE MUST BE USED. IF A BOWLER DOES NOT HAVE A PREVIOUS SEASON'S AVERAGE BUT HAS A CURRENT AVERAGE WITH 45 GAMES OR MORE, THE HIGHEST CURRENT AVERAGE WILL BE USED. A LEAGUE SHEET SHOWING 45 GAMES BOWLED MUST BE PRESENTED WHEN CHECKING IN. A BOWLER WHO DOES NOT HAVE AN AVERAGE WHICH IS ACCEPTABLE UNDER TOURNAMENT RULES WILL BOWL WITH A 230 AVERAGE. USBC RULE 319A & 319B WILL APPLY.
3. BOWLERS WILL BE DISQUALIFIED IF AVERAGES ARE DETERMINED TO BE INACCURATE BY THE END OF THE FIRST GAME.
4. BOWLERS ARE RESPONSIBLE FOR VERIFYING HIS/HER OWN AVERAGE.
5. THE TOURNAMENT DIRECTOR RESERVES THE RIGHT TO RE-RATE A BOWLER'S AVERAGE AT ANY TIME. USBC RULE 319C AND 319E WILL APPLY.
6. ANY APPEAL OR PROTEST WILL BE DECIDED BY THE TOURNAMENT DIRECTOR, USBC RULE 329.
7. TOURNAMENT PRIZE MONIES WILL BE PAID OUT IMMEDIATELY FOLLOWING COMPLETION OF COMPETITION.
8. THERE IS NO LIMIT TO PARTNERS FOR CROSSOVER DOUBLES.
9. THE ENTRY FEE IS \$60.00 PER TEAM, \$30 PER PERSON.
10. HANDICAP WILL BE BASED ON 80% OF 230.
11. BOWLERS WILL BOWL 4 GAMES, SKIPPING TWO PAIRS TO THE RIGHT. PRIZE MONIES WILL BE AWARDED TO THE TEAMS WITH THE HIGHEST CUMULATIVE TOTAL.
12. PAYOUT RATIO IS 1 : 5.
13. AUTOMATIC SCORING WILL BE USED AND SCORES WILL BE TRANSFERRED TO THE OFFICIAL TOURNAMENT RECAP SHEETS BEFORE THE SCORES ARE ERASED.
14. ALL BOWLERS WILL SIGN OFFICIAL SCORE SHEET. OFFICIAL SIGNATURE WILL BE CONSIDERED AS FINAL APPROVAL.
15. THERE WILL BE 10 MINUTES OF PRACTICE.
16. ONCE PRACTICE HAS CONCLUDED ALL BRACKETS/SIDE POTS WILL BE CLOSED.
17. ANY BOWLER USING VULGAR LANGUAGE, DISPLAYING DISRUPTIVE BEHAVIOR, UNSPORTSMANLIKE CONDUCT OR ABUSING BOWLING CENTER EQUIPMENT OR NOT FOLLOWING THE TOURNAMENT RULES WILL BE DISQUALIFIED FROM THE TOURNAMENT.

DIRECTIONS TO AMF FREDERICKSBURG BOWL

- EXIT 130B OFF I-95 TO MERGE ONTO VA-3W/PLANK RD TOWARDS CULPEPPER.
- FROM THE EXIT, HEAD WEST ON VA-3W/PLANK RD FOR 2.5 MILES.
- TURN LEFT ON CHANCELLORS VILLAGE LANE.
- TURN RIGHT TO STAY ON CHANCELLORS VILLAGE LANE.
- CONTINUE ACROSS KILARNEY DRIVE TO THE AMF PARKING LOT ON THE LEFT.
