- 1 CHECK-IN will begin one hour prior to scheduled squad time. Check-In will be on an individual basis and 2016-2017 USBC membership cards must be presented at Check-In. Announcements will be made 15 minutes before squad time. Practice will begin ten minutes before squad time. Bowling for score will begin at squad time.
- 2 TARDINESS: Any player arriving late shall begin play with the frame in progress. Zero (0) will be given for frames missed and shall begin play with the frame then being bowled.
- 3 EMERGENCIES: No change will be made in the entrant's scheduled time of bowling after February 25, 2017 except for an emergency. The Tournament Manager must approve all changes to the schedule.
- 4 ELIGIBILITY: All entrants must be Adult and certified by the United States Bowling Congress (USBC) and be a member of Greater Fredericksburg USBC (GFUSBC).
- 5 DRESS CODE: Bowlers are requested to wear suitable attire when participating in the GFUSBC Championship tournament no obscene or pornographic pictures or language.
- 6 ENTRY FEE: Handicap Events will be \$25.00 per person per event with \$12.50 for Prize Fund; \$9.50 for Lineage and \$3.00 for Expense Fee. All-Events fee (optional) will be \$5.00 with \$4.50 for Prize Fund; and .50 for Expense Fee. Optional Scratch Events will be \$10.00 per event \$9.00 Prize Fund and \$1.00 Expense Fee. All-Events Scratch (optional) will be \$5.00 with \$4.50 for Prize Fund and .50 for Expense Fee. Scratch Team requires all team participants to enter optional scratch. Scratch Doubles requires both participants to enter optional scratch. Bowlers entering singles must also enter doubles and vice versa. Entry fees may be remitted by Personal Check, money order or cash. -- All applicable bank fees will be charged for any personal checks returned by the bank. Payments in cash must be submitted in a secure manner. NO ENTRY FEE WILL BE REFUNDED AFTER ACCEPTED.
- 7 MULTIPLE ENTRIES: Multiple and Reentries will be allowed. There must be a change of at least two (2) team members in the Team Event. There must be a change of one (1) person in the Doubles Event. An individual may place multiple times. The first series bowled in each event will count towards allevents.
- 8 HANDICAP: 90% of the difference between the individual's average and 240.
- 9 SUBSTITUTIONS: If a scheduled entrant cannot participate, a substitute may be used, providing they are not in violation of the multiple entry rule. Substitutions, along with average verification must be reported at least ONE HOUR BEFORE bowling time to the Tournament Manager. The substitute shall take the place in the line-up of the original entrant. A substitute replacing a bowler who entered in all-events shall be entered in all-events automatically provided the substitute replaces the original bowler in all of the events and provided transfer of all-events has not been otherwise designated. The original bowler will forfeit the right to bowl in the event. In case of disability after a game has started, a substitute will be permitted and replace the disabled bowler in the event. The combined score will count for that event. In the case a tardy bowler arrives after a substitute has bowled, the substitute shall complete the series in progress. If the Division changes because of a substitution, the results shall be classified into the appropriate Division for that event.
- 10 ENTRY DEADLINE is February 19, 2017
- 11 ENTERING AVERAGE: Entrants will use: Highest USBC average of the 2015-2016 winter seasons of 21 games or more. If the bowler does not have a 2015-2016 average, use the highest average as of February 1, 2017* for 21 games or more from a current GFUSBC certified league; If entrant does not meet any of the aforementioned requirements for average, a 240 scratch average will be used (USBC Rule 319b). *February 1, 2017 league averages must be supported by an Average Verification form from all leagues the bowler has competed in with the league sccretary's signature and supporting Bowler History Standing Sheets are acceptable.

12 AVERAGE VERIFICATION. The following rules apply: USBC Rule 319.a.2 (current average 10 pins higher than the Highest average for the previous year). a. It is the bowler's responsibility to verify the accuracy of their average, whether submitted by the bowler, their captain, or others. Failure to use the proper average shall disqualify the score if submitted average is lower than the correct average, resulting in more handicap. Prize winnings shall be based on the submitted average if it is higher than the correct average. Average corrections must be submitted in writing within 48 hours after completion of

the first event bowled.
b. Emergency substitutes without a verified average may bowl using a 240 average. Written verification of average will be due within seven days of the bowling date in order to correct average, handicap, and classification.

c. Average Adjustments (Rerating): The average of a bowler may be adjusted upward before participation in any event. If the assigned average is not accepted by the bowler, the entry fee shall be refunded.

- 13 EVENTS: The team must consist of 2 males and 2 females. Doubles must consist of 1 male and 1 female. All Doubles entries will be in one division. Singles shall consist of 1 division for men and 1 division for women. ALL-EVENTS (optional): Entries will consist of 1 division for men and 1 division for women. The cumulative individual total of handicap scores from the first event bowled in singles and doubles events will be used for All-Events.
- 14 FORMAT: Line-up will be in the same order as listed on the Entry Form. Center scoring system will be used as the official scores. Pacers are not permitted.
- 15 PRIZES: Prize money will be returned 100%. Prize money shall be sent to the team captain within 30 days after the tournament ends. The team captain shall distribute the prize money within 30 days of receipt. Prize checks will be void 90 days after the date of issuance. Prizes will be paid on a ratio of at least one (1) prize for each six (6) entries. Optional All Events will be paid on a ratio of at least one a teat on (1) in ten (10). Each division champion will receive a trophy. In the event of a tie for championship, Co-champions' will be declared and prize money will be divided equally. Duplicate awards will be presented. The bowler who places first in the handicap all-events shall be entitled to the title and trophy (regardless if the bowler has not paid the optional all-events fee).
- 16 PROTESTS: Protests concerning eligibility or general playing rules must be conveyed in writing to the Tournament Director before prize payments are made. Any dispute or disagreement shall be immediately referred to and decided by the Tournament Director. All decisions of the Tournament Director are final unless an appeal is made in accordance with USBC Rule 329. A score sheet cannot be changed after the official scorer, captain or entrant has signed it, except that obvious errors in scoring, handicap, and classification may be corrected by a tournament official.
- 17 RESTRICTIONS: No Alcohol will be allowed on Saturday Morning squads. BANNED SUBSTANCES: The use of such substances as talcum powder, pumice, rosin, etc., on shoes, or the use of soft rubber soles and heels that rub off and in any manner may alter the normal conditions of the approach, is strictly prohibited.
