10th Annual Greater Fredericksburg USBC Open Championship

- 1. **ELIGIBILITY:** All entrants must be certified by the United States Bowling Congress (USBC) and be a member of Greater Fredericksburg USBC (GFUSBC).
- 2. TEAM & DOUBLES EVENT FORMAT: Teams will consist of four persons. Team & Doubles can be any gender or mixed.
- 3. MULTIPLE ENTRIES: Multiple entries will be allowed in <u>Singles, Doubles and Team Events</u>, provided there is a change of at least two (2) team members in the Team Event and one (1) <u>person in the Doubles Event</u>. An individual may place multiple times in the Team and Doubles Events, but only once in the Singles Event. The first series bowled in each event will count towards allevents.

4. TOURNAMENT AVERAGE: Entrants will use:

- (1) Highest 2013-2014 <u>USBC Composite Book Average;</u>
- (2) If (1) does not apply, use the highest average as of February 1, 2015* for 21 games or more from a current GFUSBC certified league;
- (3) If entrant does not meet any of the aforementioned requirements for average, a 240 scratch average will be used (USBC Rule 319b).

*February 1, 2015 league averages must be supported by an Average Verification form <u>from all leagues you have</u> <u>competed in</u> with the league secretary's signature and supporting <u>Bowler History</u> – Standing Sheets are not acceptable.

The following rules are waived: USBC Rule 319a2 (current average 10 pins higher than last year), USBC Rule 319d (reporting prize winnings); and USBC Rule 319e (re-rate).

5. AVERAGE VERIFICATION:

It shall be the bowler's responsibility to verify the accuracy of their average in handicap tournaments, whether submitted by the bowler, their captain or others. Failure to use proper average shall disqualify score if submitted average is lower than actual average; thereby, resulting in more handicap. Prize winnings shall be based on submitted average if it is higher than actual average. Correction of averages must be submitted in writing within 48 hours after the completion of the first event bowled.

6. HANDICAP: 90% of the difference between the individual's average and 240 based on three games.

7. ENTRY FEE:

Handicap Events will be \$25 per person per event -

\$12.75 Prize Fund; \$9.00 Lineage and \$3.25 Expense Fee. All-Events fee (optional) will be \$5.00 - \$4.50 Prize Fund; and \$.50 Expense Fee.

Optional Scratch Events will be \$10 per event - \$9.00 Prize Fund and \$1 Expense Fee. All-Events (optional) will be \$5 - \$4.50 Prize Fund and \$.50 Expense Fee. <u>Scratch Team and Scratch Doubles</u> requires entry by all participants on your entry.

- 8. Entry fees may be remitted by Personal Check All applicable bank fees will be charged for any personal checks returned by the bank. Overpayments of less than \$1 will not be refunded.
- **9. PRIZE MONEY:** All prize money will be returned 100%. Prize money shall be sent to the team captain within 30 days after the tournament ends. The team captain shall distribute the prize money within 30 days of receipt. Prize checks will be void 90 days from the date of issuance.

All of the cash awards will be paid on a handicap basis with the exception of the optional Scratch Events where awards will be based on actual pin fall. Prizes will be paid on a ratio of <u>at least</u> one prize for each 10 entries. All Events will be paid on a ratio of at least 1 in 20. Each event champion will receive a trophy. In the event of a tie for championship, Co-champions will be declared

and prize money will be divided equally and duplicate awards will be presented. The bowler who places first in any All-Events shall be entitled to the title and trophy regardless if they have not paid the optional All-Events fee; cash awards will be awarded to paid entrants only.

- 10. TARDY PLAYERS: Any player arriving after the game has started will be allowed to bowl and score(s) will count beginning in the frame then being bowled. <u>No score (0) will be given for frames missed</u>.
- **11. SUBSTITUTES & REPLACEMENTS:** No substitute or replacement will be accepted for All-Events participation when any one event, or portion of an event, has been bowled by the original entrant or another substitute.

12. OTHER:

prohibited.

Bowlers entering singles must also enter doubles and vice versa. The Doubles event shall be bowled first. 10 minutes of practice will be permitted. Telescores will be used as the official scores. Singles & Doubles will be bowled on the same pair of lanes. Pacers are not permitted. The use of such substances as talcum powder, pumice, rosin, etc., on shoes, or the use of soft rubber soles and heels that rub off and in any manner may alter the normal conditions of the approach, is <u>strictly</u>

- **13. PROTESTS:** Protests concerning eligibility or general playing rules must be conveyed <u>in writing</u> to the Tournament Director before prize payments are made. Any dispute or disagreement shall be immediately referred to and decided by the Tournament Director. A score sheet cannot be changed after the official scorer, captain or entrant has signed it, except that obvious errors in scoring, handicap, and classification may be corrected by a tournament official.
- **14. DECISIONS:** All decisions of the Tournament Director are final unless an appeal is made in accordance with USBC Rule 329.
