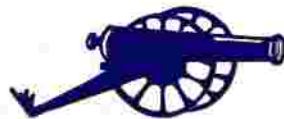

### Rules of the 2010 Annual Meeting

We, the GFUSBC Board of Directors, present for your approval the following rules to govern the 5th Annual Meeting of the Greater Fredericksburg USBC Association.

1. Roberts Rules of Order, Newly Revised, will govern the procedure of this Annual Meeting, provided it does not conflict with the Bylaws of the GFUSBC.
2. Members' credentials shall be accepted no later than 2:30 p.m. on Saturday, April 3, 2010, except when authorized by the members seated for the meeting. All members and Board of Director members shall have the privilege of voice and vote.
3. A member wishing to be recognized must properly address the Chair and clearly state his/her name in full.
4. All motions submitted at the 5th Annual Meeting shall be stated in the affirmative. Any proposed amendments contained in the Legislative Committee Report do not require a motion or a second and the Committee chairman will make a recommendation For or Against adoption.
5. At the direction of the President, the proposer of an amendment may be required to submit an amendment in writing with a copy to the Chair before or at the time it is proposed from the floor.
6. A member shall be permitted to speak only twice on any question, limiting each discussion to two minutes. Discussion shall be confined strictly to the motion on the floor and all questions and answers shall be directed to the Chair.
7. In order to expedite the business of the 5<sup>th</sup> Annual Meeting, the members shall give courteous and full attention to the speaker having the floor.
8. Members desiring to leave the meeting and not planning to return shall notify the Sergeant-at-Arms. Ballots shall be turned in at the door.
9. Visitors and guests shall be seated by the Sgt-at-Arms.
10. Members must be present to be eligible for door prizes.
11. Exceptions to these rules may be made at the discretion of the presiding officer.

With due notice having been given in accordance with USBC Bylaws, President Paul L. Rumbaugh, II called the meeting to order at 1:10 PM.

President Rumbaugh welcomed the attendees and introduced the GFUSBC Board of Directors.

#### Credentials

Phylliss Massaro, GFUSBC Sergeant-at-Arms, gave her credentials report. In attendance were 4 GFUSBC Officers, 6 GFUSBC Directors, 17 GFUSBC Members, a total of 27 eligible to vote on all issues, and 5 eligible to vote on Youth issues, with a total in attendance of 27.

#### Rules Governing the 2009 Annual Meeting

Rules governing the Annual Meeting were read by Skip Frey, who moved they be accepted. Seconded and approved.

#### Actions on the 3<sup>rd</sup> Annual Meeting Minutes

After a few minutes for review, the minutes were accepted as written.

#### President's Report

The President stated that as his two-year term comes to a close, it's time to reflect on the past year. Although he's enjoyed being your Association President, it certainly takes much more time than he anticipated. He further stated that he has gained a great appreciation for the past and present board members, who unselfishly donate their time and energy to make this organization successful.

The President reported that our membership dropped about 8 percent from last year and mirrors the trend happening across the country over the last several years. USBC is going to change many things about how they do business and those changes will dictate changes we also will have to make. More information will come out at the USBC Convention later this month and over the summer.

The President, continued by stating that with the drop in membership, the Board of Directors voted to add \$3,000 to the Association tournaments' prize funds in an attempt to increase participation. However, this action achieved mixed results -- participation dropped in the Women's and Youth tournaments, while the Open grew slightly and the Senior tournament grew by 1/3.

The President touched on some of the Board's accomplishments over the past year. GFUSBC now has a new logo approved by USBC that complies with USBC's branding requirements. The logo was applied to a new shirt for each Board member, so they would be recognized at GFUSBC tournaments and state and national meetings. The Registered Volunteer Program was started. The GFUSBC Board set the example by every member going through a national background check and being registered with

USBC, along with many of the youth volunteers to ensure our youth our protected and bowl in a safe environment. Timeliness of award processing has also improved.

The President congratulated Brenda Chambers for being named the VA State Youth Volunteer of the Year for her unfailing support of the Massaponax youth program. He also mentioned that, in June, the Virginia State men's, women's, and youth organizations will form one merged association that will be looking for local associations to host tournaments in 2011. We will be discussing this during upcoming board meetings and with our center managers to see if we can bring one to Fredericksburg.

The President closed his address by thanking everyone for attending today's annual meeting and showing that you care about your Association. He reminded all in attendance that this is their Association and the Board works for you and all the members of the GFUSBC to promote the sport of bowling.

#### Association Manager's Report

Association Manager Frey provided the following:

#### Membership Report:

As of March 31<sup>st</sup> the membership total was 2,185 (1,993 adult and 192 youth memberships) – a decrease in membership of 181 from this time last year.

#### Leagues:

We had 35 winter leagues for the 2008-2009 season.

#### Workshop:

GFUSBC held a workshop on August 11, 2008. The Association was able to present relative information to everyone at one time. Everyone benefited from the group presentation and participation. League secretaries were able to pick-up their league kits for the winter season which gave them ample time to prepare for the start of their leagues.

This year's workshop will be held on August 8<sup>th</sup> at the Harrison Road Community Center.

#### League Award Distribution

In the 2007-2008 season there were numerous comments about delays in getting awards back to league secretaries. Several factors – the inexperience of both the Association Manager and Awards Committee Chairman, and the less than timely submission of award applications by many of the league secretaries – were major contributors to these delays. Consequently, one of my top priorities for 2008-09 was to make the awards process more timely. Frey was pleased to report that there has been great strides made in this area. Overall, the association has met their goal of getting awards back to the respective league secretaries 30 days from receipt – in many cases a week after award application submission. A major factor in us being able to achieve this goal is the dedication of the league secretaries to file award applications in a timelier manner. This timeliness in filing applications has a direct correlation with an increase use of email to transmit applications. As a result,

through March 31<sup>st</sup>, the association has processed over 5,100 USBC and local awards. In addition, we have processed 49 Honor Score awards. Thanks to both the league secretaries and Bobby Phillips, Chairman of the Awards Committee, for their efforts in improving our award process.

### GFUSBC Tournaments

Association sponsored tournaments held during the 2008-09 season had mixed results. In hopes of increasing tournament participation the Board of Directors allocated an additional \$3,000 into the 4 association sponsored tournaments' prize funds. In addition, the Board authorized the lowering of the minimum age for entry into the Seniors Tournament to 50 years old. These two actions seemed to have a positive impact on the Seniors Tournament which saw overall participation increase by 32 percent. This was not the case in the Open Championship which saw its numbers remain relatively unchanged. However, participation in the Women's and Youth Championships declined by 35 and 17 percent, respectively. The following is a synopsis of the 4 tournaments held during the 2008-09 winter season.

GFUSBC Senior Tournament: The Senior Tournament was held at Liberty Lanes - Stafford November 15<sup>th</sup> and 16<sup>th</sup> 2008. There were 33 Doubles, 65 Singles, and 61 All Events participating with a total prize fund of \$2,154.50, which included \$500 in additional sponsorship. Next year's tournament is scheduled to be conducted in November 2009, at AMF Fredericksburg.

GFUSBC Women's Championship: The Women's Championship was held at Liberty Center - Massaponax, January 10<sup>th</sup> and 11<sup>th</sup>, 2009. There were 20 Teams, 40 Doubles, 80 Singles, and 89 All Events (80 in the handicapped event and 9 in the scratch event) with a total prize fund of \$3,540.50, which included \$500 in additional sponsorship. Next year's tournament is scheduled for January 2010, at Liberty Lanes - Stafford.

GFUSBC Youth Championship: The Youth Championship was conducted at Liberty Lanes - Stafford on February 14<sup>th</sup> and 15<sup>th</sup> 2009. There were 15 Teams, 29 Doubles, 73 Singles (58 handicapped event and 15 in the optional scratch event), 53 All Events with a total prize fund of \$3,091, which included \$1,150 in additional sponsorship. The entire prize fund was distributed through the USBC SMART scholarship program. Next year's tournament is scheduled for February 2010, at AMF Fredericksburg.

GFUSBC Open Championship: The GFUSC Open Championship for all Adult members was held at AMF, Fredericksburg on March 7<sup>th</sup> and 8<sup>th</sup> 2009. There were 46 Teams, 97 Doubles, 194 Singles, and 164 All Events entries. In the optional Scratch division, there were 8 Teams, 19 Doubles, 43 Singles, and 36 All Events entries. The total prize fund was \$10,137 which included \$2,500 (\$1,500 from the association and \$1,000 from private sources) in additional sponsorship. Next year's tournament is scheduled for March 2010, at Liberty Center - Massaponax.



### 2009-2010 MEMBERSHIP FEES

Relative to Adult membership fees there has been no indication from USBC what the fees will be for the upcoming 2009-2010 season. We have been informed that the award program will change in 2009-2010. More details on these changes will be provided at the Association workshop in August 2009.

Relative to the Youth program, the fee structure will increase by \$3.75, as follows:

#### 2009-2010 YOUTH DUES

USBC Membership	\$ 14.50
Processing Fee	\$ 2.00
State USBC Youth	\$ 0.50

The USBC Membership portion will increase by \$5. This increase will be partially offset by eliminating the \$3.25 local association dues and replacing it with a \$2 processing fee. State dues remain unchanged. In order to encourage youth participation the USBC will also change the process for youth sanctioning. Bowling centers will now have the option of sanctioning their youth leagues directly. Although the USBC anticipates that most youth sanctioning will be done by local associations, the current WinLabs system will no longer be used for youth sanctioning and awards, but will be replaced with an internet based system. According to discussions with an USBC youth official, the increase in dues will be used for more and nicer awards and, hopefully, a bowling shirt for each participant. Additional details on changes to the Youth program will be provided at the Association Workshop in August 2009.

### Charitable Donations

The Association Manager presented the following status of BVL and Susan G. Komen collection efforts.

BVL (Bowlers to Veterans Link). Collection drives were made at each tournament and GFUSBC event. Moreover, several leagues have taken the pledge of support by donating a portion of their 50/50 league drives. As of April 1<sup>st</sup>, GFUSBC has collected \$1,347.20 for BVL this fiscal year.

Susan G. Komen. As of April 1<sup>st</sup>, GFUSBC has collected \$1,171.33, for the USBC Bowl for the Cure this fiscal year.

# **OFFICER REPORTS**

## President's Report 2009 - 2010

The 2009 – 2010 winter bowling season is rapidly coming to a close and summer leagues will soon be organizing. I'm sure you have all noticed by now the changes USBC has made in an attempt to stop the decline in membership. USBC changed the awards program, allowed rule changes for leagues, and made massive changes to the Youth Program, all affecting our local organization. Our adult and youth membership dropped 3% and 13% respectively this year, numbers less than the nationwide statistics.

Despite a drop in membership, our four tournaments maintained approximately the same number of participants as last year. The Youth tournament was down slightly, but this could be contributed to the eligibility changes. The Association again added \$3,000 to the various prize funds.

I want to highlight some of the Board's accomplishments over the past year. The lane certification committee certified every center in the Association. The publicity committee improved the newsletters, now printing them in color. The fourth and last newsletter for this season will be published later this month. We have a very attractive and easy to use web page that is continuously updated with high scores, averages, and tournament news. The awards committee is working up some changes to the awards program for next year. Timeliness of award processing continues to improve. The ways and means committee stocked up some GFUSBC logo shirts and other items that were pretty popular. The scholarship committee interviewed candidates and dispersed \$1,000 in scholarship money.

Youth bowlers from AMF Fredericksburg and Liberty Centers Stafford and Massaponax traveled to Indianapolis for Youth Nationals and are busy raising funds for their trip to Indianapolis again this year.

Courtney Tripp, the tournament director for the Historic Fredericksburg Women's tournament asked us to run brackets and an instant raffle table during her tournament last June. The Board of Directors voted to donate all of the proceeds to our charities, the Susan G. Komen Fund for the Cure and Bowlers to Veterans Link. Our efforts raised over \$1,600 split between the two.

In June, the Virginia State men's, women's, and youth organizations formed one merged association. The merged association was looking for local associations to host tournaments in 2011. We submitted a winning bid to host the 2011 Mixed State Tournament during three weekends in February. The team event will be at AMF Fredericksburg and Liberty Center Massaponax will host the singles and doubles competition. This will force us to adjust our local tournament schedule next year. We'll also be looking for some volunteers to assist us. We typically run our Association tournaments with just Board members and a couple of other volunteers. The Mixed Tournament will require us to have 10 – 12 people at each Center to ensure the tournament runs smoothly. If things go well, we could have another tournament in 2013.

In closing, I'd like to thank all those that made this year a success and look forward to working with our Board members and volunteers, both old and new, in the coming year.

## ASSOCIATION MANAGER REPORT

It is my privilege to review the progress we have made this season.

### MEMBERSHIP REPORT

As of March 31<sup>st</sup> our membership total is 2,107 (1,940 adult and 167 youth memberships.) This is a decrease in membership of 78 from this time last year.

### LEAGUES

We have 33 winter leagues for the 2009-2010 season

### WORKSHOP

A GFUSBC workshop was held on August 8, 2009. The Association was able to present relative information to everyone at one time. Everyone benefited from the group presentation and participation. League secretaries were able to pick-up their league kits for the winter season which gave them ample time to prepare for the start of their leagues.

This year's workshop will be held on August 7<sup>th</sup> at the Harrison Road Community Center.

### LEAGUE AWARDS

I'm happy to report that we have remained very timely in the distribution of GFUSBCA and USBC awards to the adult league bowlers. I'm sorry to say that this is not the case with our youth leagues. Since USBC took our youth bowlers out of WinLabs and put them into a web-based system, pulling of local awards for the youth has become a more time consuming task. Relative to USBC Youth Awards, the increase in the number of available awards and a major loosening of award criteria dramatically increased the workload.

### GFUSBC TOURNAMENTS

The Board of Directors continued to allocate an additional \$3,000 into the 4 association sponsored tournaments' prize funds and tournament flyers were distributed earlier in the year. As was the case last year, the 2009-2010 Association sponsored tournaments had mixed results. Details of tournament participation can be found in the Tournament Committee Report.

#### GFUSBC Senior Tournament

The Senior Tournament was held at AMF on November 14<sup>th</sup> and 15<sup>th</sup> 2009. There were 30 Doubles, 50 Singles, and 45 All Events participating with a total prize fund of \$1,840, which included \$500 in additional sponsorship.

Next year's tournament is scheduled to be conducted in November 2010 at Liberty Center - Massaponax.

#### GFUSBC Women's Championship

The Women's Championship was held at Liberty Center – Stafford on January 23<sup>rd</sup> and 24<sup>th</sup>, 2010. There were 25 Teams, 51 Doubles, 102 Singles, 97 All Events



(Handicap) and 16 All Events (Scratch) with a total prize fund of \$4,250.50, which included \$500 in additional sponsorship.

Next year's tournament is scheduled for January 2011 at AMF.

#### GFUSBC Youth Championship

The Youth Championship was conducted at AMF on February 13<sup>th</sup> and 14<sup>th</sup> 2010. There were 12 Teams, 25 Doubles, 50 Singles (Handicap), 5 Singles (Scratch), 42 All Events with a total prize fund of \$2,565.50, which included \$1,000 in additional sponsorship. The entire prize fund was distributed through the USBC SMART scholarship program.

A date for next year's tournament has not been determined. Normally this tournament is held in February, but the Association will be hosting the Virginia State Mixed Tournament in February 2011. The youth tournament, whenever held, will be at Liberty Center – Massaponax.

#### GFUSBC Open Championship

The GFUSC Open Championship was held at Liberty Center - Massaponax on March 6<sup>th</sup> and 7<sup>th</sup> 2010. There were 47 Teams, 99 Doubles, 198 Singles, and 177 All Events entries. In the optional Scratch division, there were 6 Teams, 20 Doubles, 43 Singles, and 36 All Events entries. The total prize fund was \$10,407.50 which included \$2,500 (\$1,500 from the association and \$1,000 from private sources) in additional sponsorship.

Next year's tournament is scheduled for March 2011 at Liberty Center- Stafford.

#### CHARITABLE DONATIONS

Collection drives were made at each GFUSBC event and the Association periodically donated a portion of bracket/instant raffle profits. Moreover, several leagues have taken the pledge of support by raising funds by holding various fund raising projects.

#### BVL (Bowlers to Veterans Link)

As of April 1<sup>st</sup>, GFUSBC has collected \$1,888.49 for BVL this fiscal year.

#### Susan G. Komen

As of April 1<sup>st</sup>, GFUSBC has collected \$3,059.54, for the USBC Bowl for the Cure this fiscal year.

I did find that before the new manager had taken over that there were a number of finance charges and late fees on the Visa account. Since the new manager has taken over this problem seems to be alleviated.

I do however have a few suggestions to make the audit easier in the future:

- A. I suggest that each check written have back-up to show why the check was written.
- B. Each deposit should have back-up to show where the money came from.
- C. That the board address outstanding checks; some over two years old.

My audit of this organization shows that it is fiscally sound with just a few minor financial procedures that need to be altered.

Committee Actions:

- Ø Lane certification inspections were conducted and discrepancies were corrected at AMF Fredericksburg (50 lanes), Liberty Center Massaponax (48 lanes), Liberty Center Stafford (30 lanes) and Cannon Ball Lanes (10 lanes) during April through August 2009. All centers met the USBC specifications. The USBC requirements that certification inspection be conducted prior to the beginning of each bowling season (first day of August). They recommend that inspections begin in May in order that the centers can correct the discrepancies prior to beginning of the bowling season. The Greater Fredericksburg USBC Association certification inspections will begin the last week in April of 2010 for the 2010-2011 bowling season.
- Ø Lane dressing tapes were made at the four (4) centers during September and October of 2009. A second set of tapes were made at Cannon Ball Lanes in March 2010 (lane dressing machine went through a major repair process). All centers met USBC standards. The USBC requirements are that tapes be made for each center once during the bowling year. The tapes for the 2010-2011 bowling year will be made in the September and October 2010 time frame.
- Ø AMF Fredericksburg, Liberty Center Massaponax and Liberty Center Stafford are certified to conduct Sport Bowling leagues. Only the PBA Experience (sport pattern) league at Liberty Center Stafford was certified during the 2008 – 2009 season. That league will be certified for 2009 – 2010 summer season.
- Ø I would like to thank all the people that assisted in the lane and lane dressing certification inspections. They were Deborah Johnson, Chuck Husted, Larry Roath, Dick Jaco and Bobby Phillips. I would like to say that the management and personal at each center were very helpful and cooperative. This allowed us to make the inspections at the most convenient time for all involved. Thank you again.

The goals of the Public Relations Committee for 2010 and 2011 are multiple. The committee is responsible for advertising and promoting Greater Fredericksburg USBC (GFUSBC) events as required by the various committee chairmen and The Association Board of Directors. These include, but are not limited to, bowling tournaments, general membership meetings, elections and special events. We accomplished this in a variety of ways.

Flyers are designed and distributed to association members to announce upcoming functions as required by the Board of Directors and any of the working committees. We personally promote upcoming events, like the Senior Tournament, while distributing the Lanes and Frames newsletter. Posters are designed and placed in bowling centers to publicize association tournaments.

Larry and Peggy Roath (association volunteer) collect association news, pictures, business advertisements and items of interest in order to write and publish the Lanes and Frames Newsletter. Contributions come from association board members, bowlers, league secretaries and the Internet. The newsletter is published four times during the year in conjunction with the Senior Tournament, Women's Championship, Open Championship and the Youth Tournament. It is an evolving documentation of association activities, adult and youth bowling accomplishments, amusing stories, information pertinent to association secretaries and members, charity drives and many other useful entertaining features. We print and distribute 900 newsletters for each of the four yearly issues available to all bowlers. Advertising helps defray the cost of printing.

As the GFUSBC Historian, Peggy Roath collects stories, memorabilia, statistical documentation, names and pictures covering association events to provide a written and pictorial history of our organization as it evolves. This information is stored, sorted and placed in albums. The information may be displayed at various association functions for viewing by the general membership.

## TOURNAMENTS

As a merged association, Greater Fredericksburg USBC is mandated by its charter to hold a minimum of three tournament competitions. These mandated tournaments are the Open Championship which is open to all GFUSBC members, a Women's Championship for women only, and a Youth Championship open to youth only. In addition, GFUSBC conducts the Senior Tournament for adults 50 and older.

Although the Board of Directors continued to allocate an additional \$3,000 into the 4 association sponsored tournaments' prize funds and tournament flyers were distributed earlier in the year, the 2009-2010 tournaments had mixed results. Participation in the Senior Tournament, after experiencing significant increases last year, dropped off slightly but remained higher than the level of two years ago. The Youth Championship declined slightly, but the abnormally harsh winter may have been a contributing factor. However, participation in the Women's Championship increased by 25 percent over the prior year. Likewise, the Open Championship saw a modest increase (4 percent) -- establishing the highest overall participation level in the history of the event. We will continue to search for additional ways to increase tournament participation, but our best source for increasing participation is for all of us to encourage others to enter these GFUSBC events.

# Greater Fredericksburg USBC Youth Committee

In the 2008-09 season the youth committee had two main goals entering the new season.

Goal one was to fill and maintain a complete Youth Committee, which consists of three adults and two youths. With the addition of Mr. Gerald Charwood we were able to make that goal.

Goal two was to continue a strong youth program within our association by having all of the programs share information and try to work more closely with each other. One of the ways we are trying to do this is to host tournaments for our youth within our own association rather than have to travel to Richmond or Northern Virginia.

We are happy to say that we met both goals and were able to build on these during the 2009-2010 season.

## Local Youth Tournaments

During the last year the youth committee, with the support of the entire Greater Fredericksburg USBC, was able to host two tournaments in addition to the youth open event held in February. The first tournament was an end of season scratch event held at AMF Fredericksburg. This was a 4 game event and was broken down into two divisions based on average. Division 1, which is bowlers with averages over 165, the winner was David Armstrong defeating Bill Symanowski in a thrilling one game roll off – 256 to 194. Both of these fine bowlers represented the Saturday Youth Legends from Massaponax. Following the initial four game series the two were tied with a series score of 819. In division 2, which was for bowlers with averages of 164 and below, the outcome was far less dramatic, though no less impressive. Samantha Wallace from the Liberty North Youth Legends league bowled a very impressive 807 series for her four game series. Patrick Downs from AMF and Jessica Callahan from Massaponax rounded out the top three. A total of \$400.00 was awarded in SMART funds for this tournament.

In October a 4 game season opener handicap tournament was held at Liberty Lanes in Massaponax. This event again drew bowlers from all three youth programs within our association. In this event the scores were based on four games bowled then the lowest score was dropped. The total of the three remaining games was added with the bowler's total handicap. Again this event was divided into two divisions. Division one was again based on averages of 165 and above. First place in this division went to Tom Brady from Saturday Youth Legends in Massaponax with a handicap series of 759. Second place went to Errin Antwine from Liberty Youth Legends Stafford and third place to Josh Myles from Massaponax. Division 2 was won by Cody Saunders from Massaponax with a handicap series of 741. Finishing second with an average of 88

was Chloe Cuff and third went to Tyler Nobles, both are from the Saturday Youth Legends Massaponax. For this tournament a total of \$448.00 was awarded in SMART funds.

The goal of the current youth committee is to continue to have these events for our youth to be able to participate in right here within our association as well other various state and national events. We also strive to provide training and coaching for the development of our bowlers teaching both basic skills as well as encouraging sportsmanship and game etiquette.
