The entrants whose names appear on the Tournament Entry or their authorized replacements hereby agree that the tournament manager shall be liable only to the extent of returning entry fees if and when these entrants shall be prevented from bowling any event in the tournament through delay, unexpected yet necessary schedule change or premature termination of the tournament which may be brought about by war, national emergency or emergencies or causes relating hereto from fires, strikes, lockouts, labor difficulties or other causes beyond the control of the tournament manager.

Alice's Historic 30th Annual Fredericksburg Women's Tournament

- 1 CHECK-IN will begin one hour prior to scheduled squad time. Check-In will be on an individual basis and 2023-2024 USBC membership cards must be presented at Check-In. Announcements will be made 10 minutes before squad time. Practice will begin promptly at squad time. Bowling for score will begin at completion of practice.
- 2 TARDINESS: Any player arriving late shall begin play with the frame in progress. Zero (0) will be given for frames missed and shall begin play with the frame then being bowled.
- 3 Previous prize winnings reporting is not a condition of this tournament
- 4 ELIGIBILITY: All entrants must be Female and certified by the United States Bowling Congress (USBC).
- 5 DRESS CODE: Bowlers are requested to wear suitable attire when participating in the Alice tournament – no obscene or pornographic pictures or language. Pink/Breast Cancer attire encouraged.
- 6 ENTRY FEE: Handicap Events will be \$30.00 per person per event with \$14.00 for Prize Fund; \$16.00 for Lineage and Expense Fee. All-Events fee (optional) will be \$5.00 with \$5.00 for Prize Fund; Scratch Events (optional) will be \$10.00 for teams, doubles, and singles with \$9.00 prize fund and \$1.00 expense fee. All-Events Scratch (optional) will be \$5.00 with \$5.00 for Prize Fund.
 - When entering scratch doubles, both partners must enter and when entering scratch teams, the entire team must enter. Entry fees may be remitted by Personal Check, money order or certified check. -- All applicable bank fees will be charged for any personal checks returned by the bank. NO ENTRY FEE WILL BE REFUNDED AFTER ACCEPTED.
- 7 LINE UP: The line up will be the same as listed on the entry form and may not be changed. Bowlers in the doubles event must enter the singles event and vice versa. There will be no rearranging or "trading" of Doubles partners. The doubles event will be bowled first.

8 THERE WILL BE NO MULTIPLE ENTRIES ALLOWED

- 9 HANDICAP: 90% of the difference between the individual's average and 220.
- SUBSTITUTIONS: If a scheduled entrant cannot participate, a substitute may be used, providing they are not in violation of the multiple entry rule. Substitutions, along with average verification must be reported at least ONE HOUR BEFORE bowling time to the Tournament Manager. The substitute shall take the place in the line-up of the original entrant. A substitute replacing a bowler who entered in all-events shall be entered in all-events automatically provided the substitute replaces the original bowler in all of the events and provided transfer of all-events has not been otherwise designated. The original bowler will forfeit the right to bowl in the event. In case of disability after a game has started, a substitute will be permitted and replace the disabled bowler in the event. The combined score will count for that event. In the case a tardy bowler arrives after a substitute has bowled, the substitute shall complete the series in progress.
- 11 ENTRY DEADLINE is July 13, 2024 Entires shall not be accepted after this date, except those postmarked the first day after the entry closing date. Walk ins may be allowed provided there is space available and are subject to a \$25 late fee.
- 12 ENTERING AVERAGE: Entrants will use: Highest USBC average of the 2022-23 winter seasons of 21 games or more. If the bowler does not have a 2022-23 average, use the highest average as of January 1st, 2024* for 21 games or more from a current USBC certified league; If the bowler does not have a January 1st average with 21 games, they may use a current USBC certified league average with 21 games or more as of the July 1, 2024 deadline date. If entrant does not meet any of the aforementioned requirements for average, a 220 scratch average will be used (USBC Rule 319b). *January 1st, 2024 league averages must be supported by an Average Verification form from all leagues the bowler has competed in with the league secretary's signature and supporting Bowler History Standing Sheets are acceptable.

- 13 AVERAGE VERIFICATION. The following USBC Rule 319.a. & 319.e are waived (current average 10 pins higher than the Highest average for the previous year).

 a. Emergency substitutes without a verified average may bowl using a 220 average. Written verification of average will be due within seven days of the bowling date in order to correct average, handicap, and classification.
- 14 EVENTS: Teams will consist of four female bowlers.
- 15 FORMAT: Line-up will be in the same order as listed on the Entry Form. Center scoring system will be used as the official scores. Pacers are not permitted.
- 16 PRIZES: Prize money will be returned 100%. Prize money shall be sent to the team captain within 30 days after the tournament completion. The team captain shall distribute the prize money within 15 days of receipt. Prize checks will be void 90 days after the date of issuance. Prizes will be paid on a ratio of at least one (1) prize for each ten (10) entries. Optional All Events will be paid on a ratio of at least one (1) in twenty (20). In the event of a tie for championship, Cochampions' will be declared and prize money will be divided equally. When ties occur in any event, prize money will be combined and divided equally. Any lost checks or replacement checks will be subject to a \$35 fee.
- 17 DISQUALIFICATION: A team using an unsanctioned bowler will be disqualified. Failure to use the correct average shall disqualify their score if submitted average is lower than the correct average, thereby resulting in a lower classification or more handicap. Prize winnings shall be based on the submitted average, if it is higher than the correct average. However, corrections in average may be permitted up to the completion of the first game of a series. A disqualified individual or team forfeits all entry fees and rights to prize money.
- 18 PROTESTS: Protests concerning eligibility or general playing rules must be conveyed in writing to the Tournament Director within 72 hours of last squad bowled. Any dispute or disagreement shall be immediately referred to and decided by the Tournament Director.
 All decisions of the Tournament Director are final unless an appeal is made in accordance with USBC Rule 329. A score sheet cannot be changed after the official scorer, captain or entrant has signed it, except that obvious errors in scoring, handicap, and classification may be corrected by a tournament official.
- 19 BANNED SUBSTANCES: The use of such substances as talcum powder, pumice, rosin, etc., on shoes, or the use of soft rubber soles and heels that rub off and in any manner may alter the normal conditions of the approach, is strictly prohibited.
- 20 LANE DRESSING: The lanes will be oiled and using the house shot.
